

Avoid Bursting Sprinkler Pipes this Winter



During the winter season, temperatures can plummet and cause pipes to freeze. When temperatures are consistently below freezing, the water within the pipes of your sprinkler system will freeze. Frozen water expands roughly ten (10) percent, which in turn, puts thousands of pounds of pressure on the pipes. Your sprinkler system pipes (and pipes in general) may not withstand that amount of pressure. Weak and corroded spots may appear within the pipe. When thawing occurs and the previously frozen water begins to flow again throughout the pipe, there is the potential for rupture at those weak spots.

Typical commercial applications, like office buildings or apartment buildings, have a wet fire sprinkler system, meaning that water is constantly flowing through the piping. Here are some

ways to avoid damage to these fire sprinkler systems from freezing and thawing:

- Many sprinkler freeze failures occur due to inadequate building heat. The best way to keep a wet fire sprinkler system from freezing in the winter is to ensure that indoor temperatures don't fall below 50°F.
- Turn off energy savings settings during extended periods of cold weather or vacancy. Extended idle periods can occur when building occupants leave for a long weekend or holiday.
- Ask your fire sprinkler maintenance company for suggestions, such as insulation.
- Get both your heating and sprinkler systems inspected and tested before cold weather strikes. Remember Elk Grove Village Fire Code requires annual sprinkler system testing to ensure your equipment is in good working condition.

At the first Village Board meeting of 2023, Elk Grove Village Mayor Craig Johnson announced that the Village Board has selected Wingspan Development Group

to partner with them to design and build a vibrant, mixeduse development that will serve as a gateway to the community.

"We're grateful to all the developers who engaged with us in this process. More importantly, we are grateful to all the residents who provided valuable input. Their feedback

certainly played a role in our selection process" said Mayor Craig Johnson.

Village staff and trustees evaluated four proposals in all, based on their ability to:

 deliver on the Village's vision to provide an attractive, modern, mixed-use development with diverse housing options that serve

as a gateway into the community;

- integrate existing retail tenants into the overall plan;
- be sensitive to the concerns of nearby residential neighbors, and:
- attract new businesses and tax revenue for the Village.

Additionally, residents who weighed in on the proposals at a recent

open house and online overwhelmingly favored the Wingspan proposal. Preliminary renderings portraying Wingspan's proposal can be viewed online at www.elkgrove.org/gateway.

Renovations for Rose Garden Café Currently Underway

Last year, the Village announced that the Rose Garden Café, a local favorite of Elk Grove Village residents for decades, will relocate to a building across the street from its current location to make way for a new "gateway" development at the corner of Arlington Heights and Higgins. The Rose Garden Café will move into a building once occupied by Sweet Baby Ray's, located at 800 E. Higgins Road, a property purchased by the Village in 2022. The Village owns the current building that is leased and occupied by the Rose Garden, but the building will need to be demolished to make room for a re-envisoned gateway to the community.

The redevelopment agreement approved last summer provided for the Village to eventually transfer ownership of the property at 800 E. Higgins to the Rose Garden in exchange for the early termination of the lease at the Rose Garden's current location, as well as renovations and improvements to the existing building at 800 E. Higgins.

This agreement further ensures that the Rose Garden Café will remain open for business without interruption and upgrade to a newly-redesigned building. Renovations for the Rose Garden Café are currently in progress. Restaurant ownership is planning on making the move to the new building in the spring of 2023.

Residents can expect to see changes to the proposed development. Final details will be ironed out with Village officials in the coming months as the Village Board works to incorporate design goals. Residents will have another opportunity to provide feedback on the development at an open house planned in the next few months before final approval.

As with all developments, the plans will be subject to additional review and approvals by the Elk Grove Village Plan Commission, a process that is expected to take several months and will include additional opportunities for residents to provide feedback and ask questions.

Wingspan Development Group is a nimble national developer focusing on multifamily, attached single-family, student housing and mixed-use developments. With in-house land acquisition, development and construction capabilities, Wingspan prides itself on its relationships and partners in key sub-markets that allow the firm to move quickly in closing deals and completing best-in-class projects on time and within budget. 

Home Remodeling Guide

It's a new year, which often brings motivation to tackle home improvement projects. If you are planning any remodeling projects, the steps below can help you get started with the process.

Step 1 - Make a list

Write down all of your remodeling ideas and create a budget.

Step 2 - Hire a contractor

Obtain at least three quotes to compare prices and the scope of work to be completed. Any remodeling work over \$1,000 requires a written contract from the contractor. Be cautious if something appears to be too good to be true, and always ask questions. Review the Consumer Rights pamphlet from the Illinois Attorney General's Office by scanning the QR code to the right.

Step 3 - Get Permits

Contractors can begin work when all building and/or engineering permits are approved and issued. Inspections are performed by Village staff to ensure all renovations are compliant with current codes, standards, and restoration practices. At the end of your project, be sure to obtain a "Waiver of Lien" from the contractors as proof of payment in full.

Green Grove: Police Department

The Elk Grove Village Police Department has aided the Village's sustainability efforts by incorporating two hybrid vehicles into its patrol fleet. Hybrid vehicles are powered by both a traditional internal combustion engine and at least one electric motor that uses energy stored in a battery. An electric generator inside the vehicle takes energy otherwise lost from slowing down a car and converts it to electricity for the battery. As a result, these cars run on less gasoline in comparison to conventional gas or diesel-powered vehicles, which helps reduce the amount of carbon emissions and other pollutants in our air.

The Police Department also uses a cloud-based document management system to reduce their paper consumption. This system allows staff to track their CALEA accreditation and training digitally rather than with paper documents. High paper consumption is a significant contributor to deforestation, excess waste in landfills, and pollution. Deforestation is the removal of forest for other land uses and has negative effects on the environment. The Police Department has been able to save an estimated 47.3 trees from being cut down and turned into paper since it began using the system!

Americans with Disabilities Act Transition Plan Survey

Elk Grove Village is in the process of creating an Americans with Disabilities Act (ADA) Transition Plan to help upgrade pedestrian facilities and public sidewalks to current accessibility standards. The Village encourages community members to participate in the decision-making process. As part of this process, a survey was developed to gain information on pedestrian accessibility issues throughout the Village's public right-of-way.

What information is the Village looking to collect?

The Village is collecting feedback related to the ADA Design Standard Guidelines, the Improvement Approach & Schedule, the Village's current Sidewalk Inventory, and your pedestrian experience with any accessibility obstacles throughout the Village.

How long will the survey remain open?

The survey will remain open from February 1 - March 10.

How can you participate?

To participate online, please visit <u>elkgrove.org/ADAsurvey</u> or scan the QR code to be directed to the survey.

Can I participate without going online?

Yes, survey packets will be available at the Village's Community Development Department, located in the Charles J. Zettek Municipal Complex at 901 Wellington Avenue.

What happens once the survey is completed?

Feedback collected from the survey and areas identified by the Village's ADA consultant will help the Village develop an ADA Transition Plan that will guide the planning and implementation of future program and facility modifications. Improvements will be identified using the following methods:

- Scheduled Street and Utility Improvement Projects: All pedestrian facilities impacted by these projects will be upgraded to current accessibility standards to the greatest extent feasible as part of the project.
- Stand-Alone Sidewalk and Right-of-Way Accessibility Improvement Projects: As necessary improvements are identified, these projects will be incorporated into the Capital Improvement Program (CIP) on a case-by-case basis.
- Private Development Projects: The Village has adopted more stringent plan submittal
 requirements for the design of curb ramps to be constructed within the public right-ofway as part of private development projects, including new subdivisions. All sidewalk
 and curb ramps constructed within the public right-of-way will be inspected by
 the Village staff to confirm compliance with ADA requirements prior to the Village
 accepting the improvements.
